



# INTERNATIONAL LIMITED WARRANTY

Garden Leisure Hot Tubs warrants to the original consumer purchaser (“you”) the following about your new portable spa, when purchased from an authorized dealer/service provider (“dealer”).

## 5 Year Structure Warranty

Garden Leisure Hot Tubs warrants the spa structure of the spa, which is defined as any rotationally molded, polyethylene internal support structures connecting the unibody shell, cabinet, floor and the external coping to be free from defects in materials and workmanship for a period of five years from the delivery date of the spa. This structural limited warranty excludes any portion of the spa that is not rotationally molded as part of the unibody shell such as jets, doors, covers, etc.

## 2 Year Shell/Surface Warranty

Garden Leisure Hot Tubs warrants the shell of the spa to be free from defects in materials and workmanship resulting in water loss for a period of five years from the delivery date of the spa. Costs including, shipping, delivery, set-up, installation and/ or disposal charges will be the sole responsibility of the spa owner.

## 2 Year No Leak Plumbing Warranty

Garden Leisure Hot Tubs warrants the factory installed plumbing components of the spa to be free from defects in materials and workmanship resulting in leaks, for a period of two years from the delivery date of the spa. This warranty only covers leaks due to defects in jet fittings, internal plumbing, internal glue joints and, hoses.

## 2 Year Component Warranty

Garden Leisure Hot Tubs warrants the electrical and mechanical components including the pump, heater, LED lighting and control system to be free from defects in materials and workmanship for a period of two years from the delivery date of the spa. Filter cartridges, light bulbs, hot tub cover, spa cover locks, and fuses, and GFCI cord are not included in this warranty. However, warranted to be free from defects in materials and workmanship at the time of delivery to the original consumer purchaser. Spa covers and other spa accessories are specifically excluded from this warranty, although they may be covered by other warranties. Please check with Garden Leisure Hot Tubs for details.

## 2 Year Synthetic Wood Cabinet Warranty

Garden Leisure Hot Tubs warrants the synthetic wood cabinet material and assembly on spas to be free from defects in materials and workmanship for a period of two years from delivery date of the spa. The cosmetic finish is warranted to be free from defects in materials and workmanship at the time of delivery to the original consumer purchaser. Fading and weathering of the surface may naturally occur over time and are not considered defects for the purposes of this warranty.

The following applies to all of the warranties listed above:

### Extent Of Warranty

This warranty extends only to the original consumer purchaser of the spa when purchased and originally installed within the country of purchase or, in case of spas purchased in the European Union (“EU”) when originally installed within the EU. This warranty begins on the delivery date of the spa, but in no event later than one year from the date of purchase. The spa warranty terminates upon any transfer of ownership or if the spa is installed or relocated outside the boundaries of the country of purchase or, in case of spas purchased in the EU, if the spa is

installed or relocated outside the EU, prior to the expiration of the warranty period.

### Warranty Performance

To make a claim under this warranty, contact Garden Leisure Hot Tubs. In the event you are unable to obtain service from the dealer where you purchase your spa, please contact our Customer Service Department (888) 961-7727 or via e-mail, [AHSService@Watkinsmfg.com](mailto:AHSService@Watkinsmfg.com) You must give Garden Leisure Hot Tubs written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Garden Leisure Hot Tubs reserves the right to inspect the malfunction or defect on location.

Garden Leisure Hot Tubs or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts and/or labor necessary to repair the spa for defects covered by this warranty. In some cases, the servicing Garden Leisure Hot Tubs may charge you a reasonable repairperson travel/service charge that is not covered by this warranty. Please contact Garden Leisure Hot Tubs for information regarding any such charges.

### Limitations

Except as described above, this warranty does not cover defects or damage due to normal wear and tear, improper installation, alteration without Garden Leisure Hot Tubs prior written consent, accident, acts of God, misuse, abuse, commercial or industrial use, use of an accessory not approved by Garden Leisure Hot Tubs, failure to follow Garden Leisure Hot Tubs Pre-Delivery Instructions or Owner’s Manual, or repairs made or attempted by anyone other than an authorized representative of Garden Leisure Hot Tubs. Alteration includes, but is not limited to, any component or plumbing change, or electrical conversion.

### Disclaimers

**ANY IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE STATUTORY PERIOD OR THE DURATION OF THE APPLICABLE WARRANTY STATED ABOVE, WHICHEVER IS SHORTER.** Some countries do not allow limitations on how long an implied warranty may last, so the above limitations may not apply to you.

**TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THIS WARRANTY DOES NOT COVER INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO THE REMOVAL OF ANY DECK OR CUSTOM FIXTURE OR ANY COST TO REMOVE OR REINSTALL THE SPA, IF NEEDED.** Some countries do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to you.
